Almost three-quarters of the school year are behind us. With the end of the year quickly approaching, I want to thank everyone who helps make our schools run so smoothly. It has been another great school year for District 102. We are truly appreciative of the efforts from students, parents, teachers and community members who help make our district so strong.

I am very appreciative that this past winter did not create a lot of havoc on our school calendar. With the writing of this newsletter, the district has not had to use any emergency days due to the somewhat mild winter we have experienced. Assuming this weather continues, the last day of school continues to be scheduled for Friday, May 25. Please remember, however, that this date will be pushed back a day for any day we may lose as a result of weather. If most of you are like me, I'm ready to bring back the sun and warmer temps that spring has to offer.

As I have mentioned in previous years, the Illinois State Board of Education, the ISBE, annually gathers financial information on Illinois school districts to determine each district's financial strength. The purpose of this data gathering process is to identify those districts that are moving towards or are already in financial difficulty. After reviewing each district's information, a financial designation profile score is calculated. Scores are accompanied by one of four ratings (listed from highest rating to lowest): Financial Recognition, Financial Review, Financial Early Warning and Financial Watch. District 102 is proud to announce that, for the ninth consecutive year, the district has achieved "Financial Recognition" status. This recent designation is based on a review of District 102's finances from the 2017 fiscal year.

With April just around the corner, it's time to think spring. Remember spring break is fast approaching. School will dismiss an hour early on March 29. The scheduled spring break will run from March 30 through April 8. Classes will resume on April 9. Let the sunny days and warmer weather return!

Enhance the Future Scholarship

The Enhance the Future Scholarship is for Pekin High School seniors who graduate during the 2017-18 school year (mid-year or end-of-year) who attended North Pekin-Marquette Heights School District 102 for, at least, six (6) years and who will be attending an accredited college, university or trade school. Students who attended District 102 Schools who still live within the District 102 boundaries, but will be graduating from a different high school may still apply for consideration. If chosen, a scholarship of \$500 will be awarded to recipients. Recipients are selected by a committee of District 102 current and/or retired staff members.

The presentation of this scholarship is made at the Georgetowne Middle School graduation at the end of the school year. This scholarship is an ongoing project originally established by Mr. David Perkins, a retired District 102 teacher with a 39-year teaching career in the district. Pre-Kindergarten Screening



North Pekin - Marquette Heights School District #102 will conduct a spring screening for the B.E.A.R.S pre-kindergarten program.

The screening dates are Thursday, May 17 and Friday, May 18, 2018. You may call for an appointment beginning April 16, 2018. **Proof of Residency must be provided before child is screened.**

The pre-kindergarten classes are held at Marquette Elementary School during the school year. The classes meet Monday through Friday for two and a half hours, either in the morning or afternoon. The classes are limited to 20 students per session. Students are invited to attend this class based on the screening results. The purpose of this class is to provide developmentally appropriate activities for students while preparing them for entrance into kindergarten.

All three and four year old children who reside in the district are eligible for screening. All children must be three by May 1, 2018 to qualify for this screening. Another screening for children, who will be three before school begins, will be held in August, 2018. If you would like to have your child screened, please call the Marquette School office (382-3612) to set an appointment beginning April 16, 2018.

Kindergarten Round-Up

Kindergarten round-up will be held Monday, March 19 through Thursday, March 29, 2018, at Marquette School. All children, who turn five years old on or before September 1, 2018, are eligible to enroll in kindergarten for the 2018-2019 school year. Parents or guardians of these children are invited to register in the school office for the spring screenings. Kindergarten screening is on Wednesday, April 18, 2018. **Proof of Residency must be provided before child is screened.**

You must bring the students' Certificate of Live Birth to pre-register your child.

It is very important for the students to be pre-registered for kindergarten at this time to plan for fall classes.

REGISTRATION FOR 2018-2019

Registration will be held in the Georgetowne library. We are also investigating having parents register online. Listed below is some information that will help speed up the registration process. Please read it over and bring all the necessary information with you when you come to register.

ALL kindergarten and sixth grade students are required to have a physical examination upon entering school. The following information is what the health department requires for these students to be in compliance.

KINDERGARTEN REQUIREMENTS

CHICKEN POX - TWO VACCINATIONS OR A DOCTOR'S LETTER INDICATING YOUR CHILD HAS HAD THE CHICKEN POX.

DPT - FOUR OR FIVE SHOTS WITH THE LAST ONE AFTER THE FOURTH BIRTHDAY

POLIO - THREE OR FOUR SHOTS WITH THE LAST ONE AFTER THE FOURTH BIRTHDAY

MMR - TWO SHOTS GIVEN AFTER THE CHILD IS 15 MONTHS OLD

LEAD SCREENING

VISION AND DENTAL EXAM FOR KINDERGARTEN

SIXTH GRADE ONLY

HEPATITIS B - THREE SHOTS WITH THE LAST ONE GIVEN SIX MONTHS AFTER THE FIRST ONE (IF NOT ALREADY RECEIVED)

Tdap - ONE TETANUS/DIPHThERIA/ACELLULAR PERTUSSIS VACINE

MENINGAOCOCCAL - ONE VACCINE ON OR AFTER 11TH BIRTHDAY

VARICELLA (chicken pox) - 2nd VACCINE OR PROOF OF DISEASE (IF NOT ALREADY RECEIVED)

DENTAL EXAMS FOR ALL STUDENTS IN GRADES KINDERGARTEN, 2 AND 6.

DIABETES SCREENING

OUT OF STATE STUDENTS

All out of state students need an Illinois physical. The requirements are the same for all immunizations.



Textbook fees for students at Marquette Elementary, Rogers Elementary and Georgetowne Middle School will be set this spring. Textbook fees should be paid at the time of registration. **A discount will be given for each student that is paid by September 14, 2018.**

At Georgetowne Middle School, this fee will include textbook rental fees and student handbook fees. Additional fees for electives or activities will also be assessed according to specific class assignments. If you need more information concerning needed supplies or materials, or the cost of these items, please contact the school office at 382-3456.

At Rogers and Marquette Elementary Schools, an additional activity fee for student magazines, assignment notebooks, recorders or journals will be assessed according to grade level. DENTAL EXAMS



House Bill 752 now requires all children in kindergarten, second and sixth grades of any public, private, or parochial school to have a dental examination. See District webpage for more information www.dist102.org/dist102.

VISION EXAMS



Effective January 1, 2008, all Illinois children in Kindergarten or upon first entry into an Illinois school beyond kindergarten are required to have an eye examination. This includes all public, private, and parochial schools. Each child is required to present proof of an eye examination by an optometrist or medical doctor who performs eye examinations. CERTIFICATE OF LIVE BIRTH

All students are required to provide a Certificate of Live Birth. This is to be obtained through the courthouse of the county in which the child was born. The copy from the hospital is not considered a Certificate of Live Birth. Some students who do not have a birth certificate on file may be asked to obtain a **Certificate of Live Birth** as stated in the student handbook. **This must be turned in to the district no later than the first day of school.**
