The Illinois State Board of Education recently released guidance to schools for the upcoming 2020-21 school year. The guidance came just prior to Illinois moving to Phase 4 later that week. The state's guidance docu-

- year. The guidance came just prior to Illinois moving to Phase 4 later that week. The state's guidance document allows for the return of students to school in the fall for in-person learning if all of the listed safety precautions can be met in each school. In particular, the guidance will:
- Require the use of appropriate personal protective equipment (PPE), including face coverings;
- Prohibit more than 50 individuals from gathering in one space;
- Require social distancing be observed, as much as possible;
- Require that schools conduct symptom screenings and temperature checks or require that individuals self-certify that they are free of symptoms before entering school buildings; and
- Require an increase in schoolwide cleaning and disinfection.

The state's 63-page document was much anticipated and serves to answer all the critical questions we all have about what the 2020-21 school year may look like. District staff members have begun reviewing and discussing the document to plan out the best option for returning students to each building in the fall. We are confident our district can put forth a plan that addresses the areas listed in the state's document. The process will take some time, but we hope to have a transition plan created and shared with parents by late July or early August.

As the start of another school year approaches and we keep our fingers crossed that students and staff will be able to return, District 102 continues its annual summer cleaning and maintenance. With the shutdown of schools in April and May, our staff got an early start to its summer cleaning. Additionally, the District is undergoing several upgrades and updates. At Georgetowne School, the District is replacing the portion of the roof over the classrooms, which will be completed by the end of July. A \$50,000 matching maintenance grant from the state will help cover a large portion of that cost. Work on the GMS gym continues as the District finishes many items remaining from an insurance claim which covered damage to the roof and ceiling of the gym in March 2019. The roof over the gym was replaced in October 2019. This summer, the gym ceiling has been cleaned and painted. The floor will be sanded, repainted and resealed as part of the required work. The District has elected to pick up the tab to paint the walls, install new mats and replace the two scoreboards. That project should be completed by the start of school.

At Marquette School, renovations on the library started in May to convert the space into a modern, 21st Century learning space. The renovation of the library is the final step in the process to renovate the libraries in each of the three buildings. At MES, old carpeting has been replaced with café-style vinyl flooring. A new coat of paint has been applied to brighten up the area. New shelving for books is being added, as well as new tables and chairs, to allow for flexible seating. The area is being redesigned to allow for greater flexibility of the space.

Finally, the district continues to increase its technology infrastructure through the use of a variety of funding sources including ESEA and ESSER grant funding. Over the summer, new laptops were purchased for all teachers and an additional 200 new Chromebooks were purchased to add to the District's current inventory of more than 200 Chromebooks. We hope to have more than 400 Chromebooks on hand before school starts to be able to issue a Chromebook to each student in grade 1-8. Approximately 400 Chromebook sleeves have been purchased to allow students to safely transport the Chromebooks back-and-forth between school and home. If there is a resurgence of the coronavirus in the fall and schools are forced to close again, we want our students and staff in a better position to return to Remote Learning.

Pre-Kindergarten at Risk Screening

September 1, 2019 and <u>NOT</u> age eligible to go to kindergarten to be screened for this school year. (If your child was screened in the spring and placed on the waiting list you do not need to have your child screened again.) If you are unable to come to registration, please call Marquette Elementary School at 382-3612 anytime Friday, July 31, 2020 for an appointment.

Kindergarten Screening for new students

Marquette Elementary School will conduct screenings for new kindergarten age children that are new to the district who were not screened last Spring. Please contact Marquette Elementary School at 382-3612, Friday, July 31, 2020 to make an appointment for this screening. The date of the kinder-garten screening is Wednesday, August 5, 2020.

Excluded are previous screened Pre-Kindergarten students.

District 102 Special Programs

Many community members, as well as parents, may not be aware of all the special services and programs offered by the North Pekin – Marquette Heights School District. Many of these programs, or services, are open to community members from ages three to twenty-one. These services include special testing for three and four year olds who may have a speech or language problem, or if the parent feels there may be a concern because of the developmental progress of their child. In such a case, district personnel could evaluate the child for speech and language services, or possible placement in an early childhood program.

Students who are currently enrolled in the local schools also have access to the many special programs that the district provides. These programs include, but are not limited to, special education classes for learning disability students, classes for students with behavior problems, services for students with speech or language deficits, as well as programs for students with visual or physical handicaps.

In addition, the district also complies with the Americans With Disabilities Act, and Section 504 of the Rehabilitation Act of 1973. If you, as a parent, feel your child needs special assistance in these areas, or any other area, please contact your local school office, to set up an appointment to discuss your concerns.

Annual Asbestos Management Plan Notice

This is to inform you of the status of the North Pekin-Marquette Heights District 102 asbestos management plans. It has been determined by the Illinois Department of Public Health and the Federal Environmental Protection Agency that asbestos is a potential health hazard, and precautions should be taken to avoid disturbing any asbestos containing materials. As required, our buildings were initially inspected for asbestos in December, 1987. The AHERA law requires that a visual inspection of asbestos containing areas be completed every six months, and a re-inspection conducted every three years. The district's three-year inspection occurred in July, 2019. Any evidence of disturbance or change in condition will be documented in the Management plan as required. The Inspection/ Management Plan is available for public review in the District Office located at Georgetowne Middle School, 51 Yates Rd., Marquette Heights. Registration fees for 2020-2021

Textbook fees for students at Marquette Elementary and Rogers Elementary are \$80.00 per student. For students at Georgetowne Middle School, the fees are \$90.00. Textbook fees should be paid at the time of registration.

A \$5.00 discount will be given for each student if this is paid by September 18, 2020.

Georgetowne Middle School has additional fees for electives or activities that will also be assessed according to specific class assignments. Also, the Board of Education will require students to wear a gown during Eighth Grade Graduation. A fee will be assessed during registration of \$25.00 to cover this cost.

Students wishing to participate in any of the following Georgetowne school activities are required to pay the following participation fees:

\$25.00 for Literary, Scholastic Bowl and Student Council. \$50.00 for Baseball, Softball, Basketball, Cheerleading, Pom Pons, Volleyball, Track and Cross Country. Maximum charge per student is \$75.00 and \$150 per family.

All Athletic fees may be waived by the building principal for those approved for a "Waiver of Fees."

At Rogers Elementary School, an additional activity fee for student magazines, assignment notebooks and recorders will be assessed according to grade level.

Marquette Students will have an additional activity fee to offset the costs of magazines, take home folders and a journal for 1st grade students.

The Parent Portal requires the use of Google Chrome, Mozilla 1.6+, Firefox 1.0+ or Microsoft Windows Internet Explorer 6.x. Most phones do not work when trying to register on-line. Parents will still need to come to registration to receive information and turn in physicals. Registration will be held in the Georgetowne Library. "Physical and Immunization Requirements" are some information that will help speed up the registration process. Please read it over and bring all the necessary information with you when you come to register.

CERTIFICATE OF LIVE BIRTH

All kindergarten students and new students to the district are required to provide a Certificate of Live Birth. This can be obtained through the courthouse of the county in which the child was born. The copy from the hospital is not considered a Certificate of Live Birth. Some students who do not have a birth certificate on file may be asked to obtain a **Certificate of Live Birth** as stated in the student's handbook. **This is due into the district no later than the first day of school.**

ALL PHYSICAL AND DENTAL EXAMINATIONS SHOULD BE DATED AFTER SEPTEMBER 1, 2019.

ALL PHYSICALS AND IMMUNIZATIONS MUST BE INTO THE DISTRICT NO LATER THAN OCTOBER 15, 2020 OR YOUR CHILD WILL BE EXCLUDED FROM SCHOOL.



PHYSICAL AND IMMUNIZATION REQUIREMENTS

ALL kindergarten and sixth grade students are required to have a physical and dental examination upon entering school. All Second grade students are required to have a dental examination upon entering school. The following information is what the health department requires for these students to be in compliance.

KINDERGARTEN REQUIREMENTS

DTP/DTaP– FOUR OR FIVE SHOTS WITH THE LAST ONE AFTER THE FOURTH BIRTHDAY

POLIO – THREE OR FOUR SHOTS WITH THE LAST ONE AFTER THE FOURTH BIRTHDAY

MMR – TWO SHOTS GIVEN AFTER THE CHILD IS 15 MONTHS OLD

VARICELLA - CHICKEN POX, IMMUNIZATION OR PROOF OF DISEASE

HIB B- 1 DOSE AT 15 MONTHS OR OLDER -NOT REQUIRED AFTER 5TH BIRTHDAY

PNEUMOCOCCAL CONJUGATE—1 DOSE AFTER 24 MONTHS - **NOT REQUIRED AFTER 5TH BIRTHDAY**

Health Examinations

Public Act 95-0422, effective August 24, 2007, revised the School Code such as that a health examination is required before entering the sixth grade of any public, private, or parochial school as opposed to entering the fifth grade of any public, private, or parochial school.

Dental Exams

Illinois Administrative Code requires all children in kindergarten, second and sixth grades of any public, private, parochial school to have a dental examination.

Vision Requirements for Illinois Students

- Vision screenings are mandatory for second and eighth grade students
- Vision screenings are recommended for grades 4, 6, 10, and 12
- Pediatric color screening is now recommended for second grade, rather than first
- Photo screening has been approved for children under 3 and for children who cannot be screened with traditional screening methods

Vision Examinations

Public Act 95-671, effective Tuesday, January 1, 2008, requires that all children enrolling in kindergarten in a public, private or parochial school and any student enrolling for the first time in a public, private or parochial school shall have an eye examination.

Each such child is to present proof of having been examined by a physician licensed to practice medicine in all its branches or a licensed optometrist within the previous year before the start of school on August 19, 2020.

BLOOD LEAD POISONING SCREENING REQUIREMENTS

The Blood Lead Poisoning Prevention Act (Public Act #87-1144) requires physicians to screen children, ages six months to six years of age, for lead poisoning. By January 1, 1993, each day care center, day care home, preschool, nursery school, kindergarten or other child care facility, licensed or approved by the State, including such programs operated by a public school district, shall include a requirement that each parent or legal guardian of a child between the ages of six months through six years provide a statement from a physician or health care provider that the child has been screened for lead poisoning. The law requires that this statement shall be provided prior to admission and subsequently, in conjunction with, required physical examinations. The Tazewell County Health Department will provide blood lead testing to those who qualify. Breakfast Program Continues for 2020-2021 School Year

All three District 102 schools will serve breakfast starting Wednesday, August 19, 2020. The basic menu is the same as last school year: Choice of 3 cereals, 3 different muffins, variety of juices and white milk

Hot breakfast will be available periodically this year. Notices and menus regarding hot breakfast will be posted to our website (www.dist102.org).

The cost for breakfast – hot or cold – is 2.35 for regular and 3.30 for reduced. Extra muffins and juice may be purchased for 4.5 each. Extra cereal may be purchased. (Not available at Marquette Elementary School) Students who qualify for free lunch will also qualify for free breakfast. Students pay daily. We also ask that lunch money and breakfast money be kept separate and that no child has more than 14.75 in breakfast and lunch charges.
