### BUILDING REPORTS

Mr. Stanley informed the Board:

- Progress reports were emailed Friday, December 5.
- On December 9, fourth and fifth grade music students and 5<sup>th</sup> grade band, participated in their winter music program.
- Eighth grade student took the Pre-ACT on December 12.
- Seven, 8<sup>th</sup> grade students will be inducted into the National Junior Honor Society on December 17.
- Fifth grade students met with educators from the TCHD who presented their maturation program on December 12.
- December 12 SIP day was used for teachers to collaborate and review the use of the new academic tools being used at GMS this year. The Special Education teachers met with Mrs. Turner to discuss state monitoring.
- Parents Club hosted the annual Secret Santa Shop on December 4 and 5.
- Eighth grade students hosted a babysitting night to start raising money for this year's 8<sup>th</sup> grade trip. Around 30 children attended.
- Boys' Basketball season will finish up after winter break, IESA regionals begin for 7<sup>th</sup> grade on January 17 and 8<sup>th</sup> grade on January 24.
- Volleyball tryouts took place on December 10 and 11.
- Annual Food Drive is finishing up collecting items for the North Pekin Fire Department Food Baskets. Items donated earn each homeroom 1 point, while "bonus" food items earned 5 points. The homeroom with the most points will earn a pizza party.
- Student Council organized "Penny Wars" during lunch to raise money to buy presents for kids in need. Funds were spent shopping for Christmas presents for families through the Center for Prevention of Abuse.
- Student Council hosted a Grinchmas themed Holiday Dance on December 12.
- Teachers and students are enjoying some holiday spirit days heading into winter break. Holiday parties will be December 19.

Mrs. Dietrich informed the Board:

### DISCUSSION ITEMS

#### Discussion of Operational Fund Expenditures and Cash Reserves Balance –

Mrs. Lindsay informed the Board that Public Act 103-0394 amends the school code to require any district that does not receive federal impact aid to calculate the combined annual average of expenditures of its operational funds for the previous three fiscal years, as reported in the school districts most recently audited financial reports. School boards must also annually present a written report at a board meeting. Mrs. Lindsay provided the each Board Member that report.

#### Transportation Updates –

Mrs. Lindsay provided updates regarding bus options for the Board to consider as the current 3-year bus lease expires in June. Mrs. Lindsay contacted three bus companies to solicit proposals. Mrs. Lindsay explained options to consider between 5 year leases and lease to own. There was discussion about what the buses could have and what is needed on them, how much mileage put on them, repairs that are needed each year and insurance coverage.

#### School Handbook Updates –

Mrs. Lindsay informed the Board that the principals have submitted handbook updates to align with the IPA Model Student Handbook and recent board policy updates. Mrs. Lindsay included those handbooks in redline format to the Board.

#### FY26 School Maintenance Grant Application –

Mrs. Lindsay informed the Board that there is an option for another round of school maintenance project grant funding. It is a 50/50 matching grant. Board Members and Mrs. Lindsay discussed different projects to apply the grant. A few projects that were discussed are the Marquette gym/cafeeteria updates, Georgetowne rooftop units and Marquette roof. Grant application deadline is January 30, 2026.
